As a consequence, the bypassed parts of these Highways, passing through the cities are no more required to be State Highways. Keeping this in view, the Governor of Punjab is pleased to denotify such bypassed stretches of State Highways where Bye-passes have been built, and these would no more be considered as State Highways.
